A. Continued discussion regarding the FY 18/19 Budget beginning on page 16

The Commission was given a change package that included modifications requested at the meeting on June 25th. Employees from the Fire Department and Public Works were present to answer any questions so the Commission reviewed their budgets first. Mayor Simmons said the budget presented shows a \$177,000 deficit when all capital items are added in.

After discussing the budget, the Commission decided to have the following modifications made before the next budget meeting. Included is \$1,755,099 in ad valorem revenue with a millage rate of 4.4286.

- \$1,400 for IEMO training in legislative budget
- Remove LDC printing
- Remove Beachcomber
- Remove Town Clerk training and associated costs for 2 years

### General Government:

- Remove impact windows and Town Hall painting from capital outlay
- Reduce Community Center painting to \$6,000
- Remove Community Center roof replacement
- Reallocate curb and sidewalk replacement to \$10,000 per fiscal year

## Fire Department:

- Fire hose replacement moved to FY20 and FY21
- Fire pagers moved to FY20

### **Public Works**

- Remove dune crossover for FY19
- Remove composite trash cans for FY19
- Remove safety tripod
- Automatic gate moved to FY20
- Add alarm system to Public Works facility for \$5,000
- Add tree trimming and stump grinding to Grounds Maintenance in place of palm tree trimming

The Commission agreed to hold another budget workshop on July 11<sup>th</sup> at 5:30 p.m. in the Masny Room.

# VI. Adjournment

Commissioner Walters made a motion to adjourn; Vice Mayor Davis seconded. Motion carried 5-0.
